2. Financial offer, in English, dated, signed and stamped, accompanied by all requested documents
3. Declaration dated, signed and stamped that it doesn't have responsibilities involving giving advice or regulation or decision-making in connection with the business and affairs of Philip Morris International and its Affiliates
4. Portfolio
5. ISO Certificates
6. Professional Certifications
